

# **Glenwood High School Hall of Fame Constitution and Bylaws**

The Hall of Fame of Glenwood High School, which includes Ball High School and Chatham High School, was created to honor those individuals or groups whose actions or achievements in their chosen fields bring honor and distinction to the heritage of Glenwood High School.

## **Categories of Recognition**

### **Achievement**

Alumni of Glenwood High School whose distinguished actions have led to outstanding recognition in their chosen fields on a local, national, or international level.

### **Athletics**

Alumni of Glenwood High School who have established outstanding records of achievement in their chosen sport which would make them deserving of special recognition. One team per year may be selected.

### **Service**

Alumni, faculty, staff, or friends of Glenwood High School whose actions and/or achievements may not be categorized in the above, but are deserving of such recognition and honor.

### **Life Time Recognition**

Alumni of Glenwood High School who shall be out of school for at least forty years and whose lives shall have reflected character and distinction.

## **Criteria for Selection**

To be eligible for selection an alumnus must have graduated from Glenwood High School at least ten years prior to nomination.

Members of the teaching faculty or coaching staff may be considered eligible five years after retirement.

One posthumous selection may be made annually.

General criteria to be considered in the evaluation are as follows:

1. A graduate or staff member whose actions demonstrate outstanding character.
2. A graduate or staff member whose outstanding citizenship has achieved international, national, or local recognition.

3. A graduate or staff member whose leadership can inspire students in the pursuit of excellence.
4. A graduate or staff member whose accomplishments are outstanding or whose leadership is considered exceptional.

Once placed on the nomination list, the nominee will remain in consideration for five years, after which time, if not elected to membership his/her name shall be removed from the list. The individual can be nominated again.

### **The Hall of Fame Committee**

Guidelines developing committee representation from a cross section of Glenwood High School and the Ball-Chatham community will consist of 15 voting and two non-voting members from the following groups:

Members at Large	3

This committee will be divided into two subgroups: nominating committee and selection committee.

A three-year term of office will begin after the banquet in April with a rotation of five new members every year. The committee shall elect the chairperson.

## **Hall of Fame Schedule**

Nominations may be made for induction following the current year's banquet.

Nominations will be due by October 1.

Hall of Fame Committee will determine candidates by November 1.

Selected candidates will be notified by November 7.

Hall of Fame banquet will be held Sunday, April 27, 2008.

## **Hall of Fame Banquet**

### Sub Committees

1. Hall of Fame Banquet Committee
  - A. Prepare Commons and Auditorium for ceremony (decorate)
  - B. Secure a caterer for ceremony
  - C. Set price and collect payment for entrance to dinner and awards ceremony
  - D. Organizes servers and dinners at ceremony
  
2. Hall of Fame Publicity Committee
  - A. Contact local newspaper, radio, TV, etc. to publicize Hall of Fame Ceremony
  - B. Put together booklet program for banquet contacting local businesses to solicit advertising in the program
  - C. Secure a printer for the program
